The Frederick County positivity rate has risen this week to 16.9 percent and remains in the threshold for twice a week COVID-19 testing. Orchard Woods conducted this week's testing on December 14 and 17 for all team members. As a result of this week's testing, we had three team members test positive with the point of care testing equipment. One additional team member is home on quarantine due to direct exposure.
